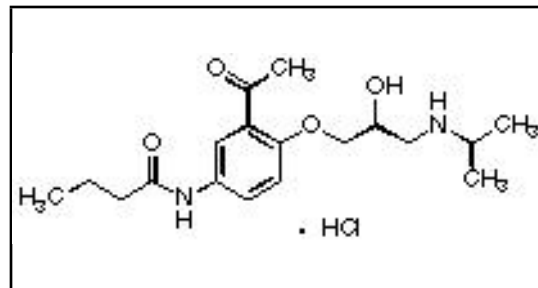

Suggested gloves: AnsellPro nitrile gloves style 92-500 or 92-600, 5 mil thickness.

Penetration time has not been determined.

Gloves used for prolonged direct exposure (immersion) should be designated "chemical resistant" as per EN 734 with the resistance codes corresponding to the anticipated use of the material.

Suggested gloves: AnsellPro Viton/Butyl gloves style 38-612, 4/8 mil thickness.
