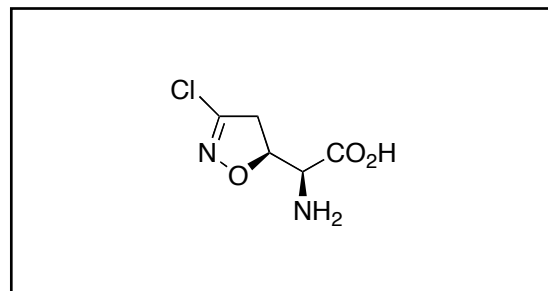

#### 4. FIRST AID MEASURES

##### General Advice

#### 7. HANDLING AND STORAGE

##### Precautions for safe handling

Avoid contact with skin and eyes. Avoid formation of dust or aerosols. Provide appropriate exhaust ventilation at places where dust/aerosol is formed. Normal measures for preventative fire protection.

##### Conditions for safe storage

Keep container tightly closed in a dry and well-ventilated place. Hygroscopic. Store at 2-8°C under inert atmosphere..

#### 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

### Respiratory protection

Where risk assessment shows air-purifying respirators are appropriate use a full-face particle respirator type N100 (US) or type P3 (EN 143) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU).

### Hand protection

Handle with gloves. Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product.
