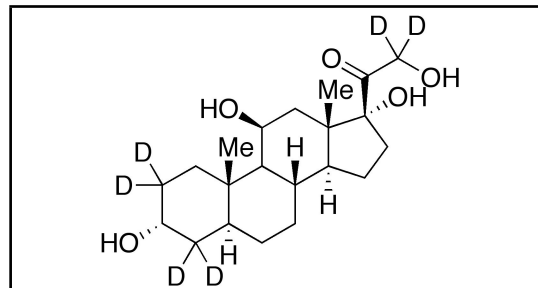

#### **Appropriate Engineering Controls**

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.

#### **Personal Protective Equipment**
