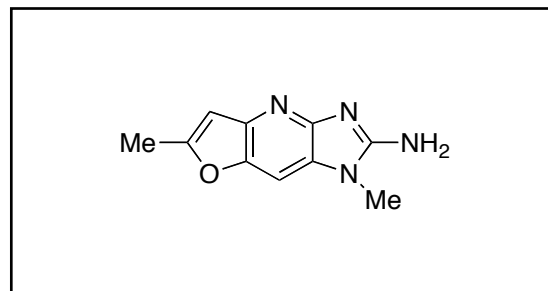

Respiratory protection
