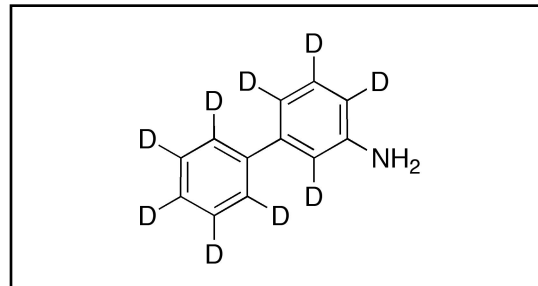

##### **Appropriate Engineering Controls**
