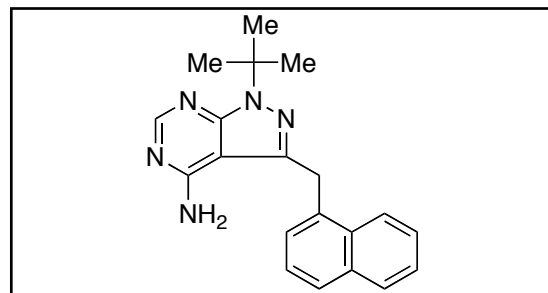

#### 4. FIRST AID MEASURES

### Respiratory protection
