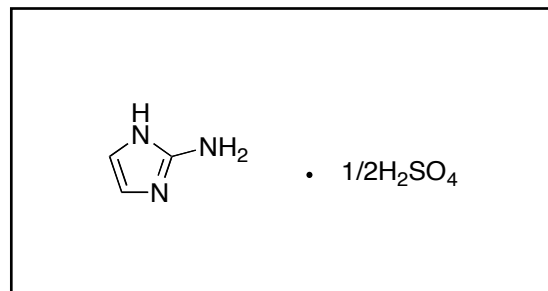

4. FIRST AID MEASURES

General Advice

6. ACCIDENTAL RELEASE MEASURES

Personal precautions

Methods and materials for containment and cleaning up
